Pursuant to the provision under Chapter-VII, Clause-48 of the Himachal Pradesh University of Health Sciences Act, 2017 and on the recommendations of the Scrutiny Committee the Hon'ble Vice-Chancellor, Atal Medical & Research University (AMRU), H.P., is pleased to grant **Provisional Affiliation** to Batt College of Nursing (Batt Educational Society), Village Bonkhri Mod P.O. Bathri, Tehsil Dalhousie Distt. Chamba Himachal Pradesh for the conduct of B.Sc. Nursing course for the Academic Session 2023-24: -

The committee has also framed the following Instruction, guidelines and recommendations for Nursing College:

1. The teaching experience must be after obtaining the essential qualification for the respective posts.
2. The daily attendance sheet should be sent to AMRU latest by 10:30 AM.
3. Biometric attendance system must be installed in each institute.
4. Sanitary Napkin & Vending Machines must be installed in each institute.
5. Deficiencies if any in respect of Infrastructure, Machinery, Faculty and Staff pointed by INC and Inspectors may be removed within 6 months.
6. Firefighting and Biomedical waste management should be as per standards.
7. The College and Hostel Building should be constructed as early possible (where ever applicable), as present arrangement will affect the teaching activity prescribed under New curriculum.
8. All the Hostels should have barbed wire fencing and Visitor Register with chowkidar.
9. The Anti-Ragging committee should be constituted and should visit the Hostel regularly and document visits, which should be communicated to AMRU every fortnight.
10. All the Faculty engaged as wardens should be provided rent free accommodation & telephone facility at residence.
11. There should be regular and surprise visit by the warden in the hostels and record of that should maintained.
12. Cleanliness of campus must be maintained.
13. Unused machinery if any in the institution should be put into use and man power recruited and trained for the same.
14. Regular meetings of College Council, Curriculum Committee, Disciplinary Committee, Anti Raging Committee, Sexual Harassment and any other committee constituted for betterment of institution should be held as per guidelines and the minutes thereof be communicated to the University within a week. Matters of urgent nature must be communicated by fastest mode at the earliest.
15. Recreation facility must be available for the students, which should consist of indoor and outdoor games. Coaches for various outdoor games must be engaged on part time basis. Play grounds may be taken on rental basis/request basis where nonexistent.

The above-mentioned approval is further subject to the following conditions failing which further action as per the Statutes and Ordinance of university will be initiated:

- a) Submission of compliance report in respect of above deficiencies along with documentary evidence within a period of Six (06) months from the date of issuance of this letter.

- b) No excess admissions shall be made by the Institutions over and above the approved intake by the INC/AMRU.
- c) The institution will not close or start new course(s) or alter intake capacity of seats without prior approval of the INC/AMRU.
- d) Institution shall not charge tuition and fees other than as prescribed by the Govt. of Himachal Pradesh/AMRU.
- e) The institution shall comply strictly with the provisions made under the Anti-Ragging Regulation notified by the UGC/INC/AMRU/State Govt. for prevention and prohibition of ragging in institution.
- f) The institute will follow the admission procedure, University Calendar, syllabus, examinations procedure and other norms/standards as laid down by the AMRU.
- g) The institution is required to submit the copy of INC approval for the Academic Session 2023-2024.
